NHCORR is, and always has been, a Coalition of Recovery House Operators who work tirelessly for the benefit of those in early recovery from substance use disorders.



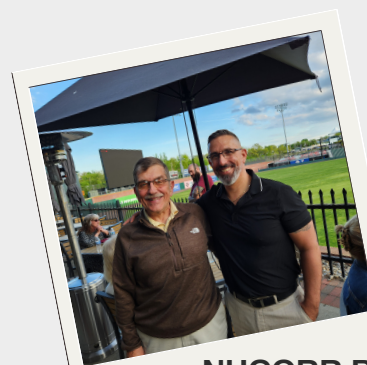

Financial Overview

Despite the fiscal challenges from the loss of state funding for operations, NHCORR was able to cut almost 50% of the funding deficit within this first year. Significant strides were made in reducing expenses and doubling down on new fundraising efforts while also moving towards utilizing volunteers in support of our programs.

New in FY25 - a paintball tournament fundraiser which raised over \$22k! And was an amazing community event! The timing of the event however forced Sober Softball later in the summer outside of the FY25 fiscal year. Another change decreasing planned income was moving to a different partnering casino for charitable gaming resulting in donations being received after FY25. NHCORR is also actively seeking operational and housing assistance grants. All is back on track for FY26.

Operating expenses were reduced by nearly \$65k in FY25. NHCORR now operates with minimal staff and made the difficult decision to close the office and go fully remote anticipating another \$60k in savings for FY26. With the help of volunteers, NHCORR not only continues to provide the highest quality NARR recognized certification and other benefits for the houses, but is also adding the additional benefit of Access-NHCORR to our program offerings!

NHCORR Advocacy



The NHCORR Advocacy Committee works tirelessly to advance policies, partnerships, and public understanding that strengthen recovery housing across New Hampshire.

Highlights of FY25:

- Strengthening key relationships: NH Doorways, NH Legislators, NH Department of Justice
- Legislative efforts: NHCORR worked with New Futures and state legislators to introduce two bills defining and protecting recovery housing in NH. While both bills were tabled, it allowed for critical dialogue with policymakers and set the stage for continued advocacy in the next session
- Resolution of Doorway System Payment Delays: NHCORR collaborated with Manchester Doorways and state partners to help resolve the significantly delayed payments of resident fees
- Active Engagement in Statewide SUD Policy Forums & National Standards: NHCORR participates in Sequential Intercept Model meetings across the state working to keep recovery housing visible, prioritized, and protected within New Hampshire's SUD framework

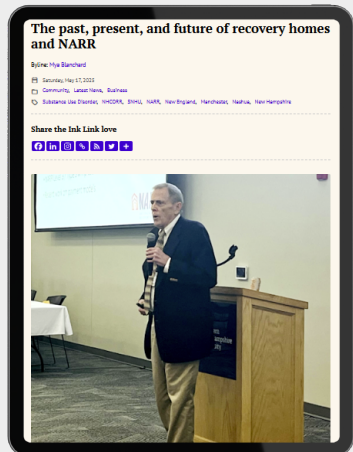

OKARR - Oklahoma's NARR Affiliate - partnered with the Appalachian Regional Commission (ARC) in a study to understand the role of **Recovery Housing** in helping individuals in recovery to become part of the workforce again. NHCORR certified homes were invited to participate as a non-ARC control group. 13 of our organizations responded to the questionnaire (thank you). The study found Recovery Housing fills a critical gap in the Recovery Eco-system.

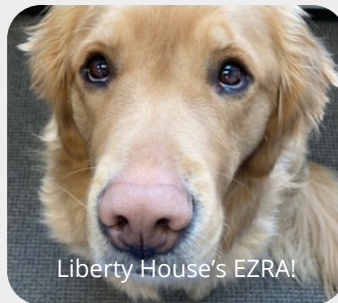

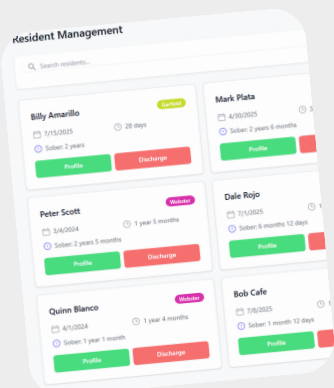

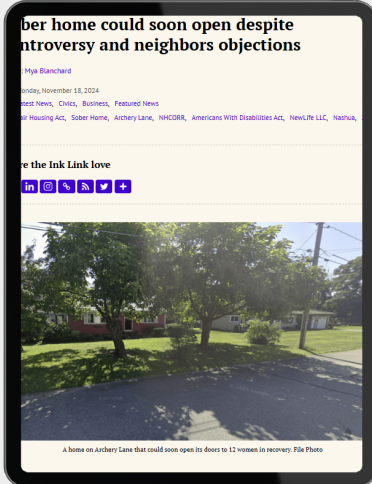
